- In the event any charges are not paid when due in accordance with this agreement, Owner agrees to be responsible for all costs of collection including attorney's fees.
- If the pet becomes ill or if the state of the animal's health otherwise requires attention, RR, at its sole discretion, is authorized to engage the services of any local vet up to \$300. If a veterinarian determines that emergency treatment, which exceeds the authorized amount, is needed to save the animal's life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment.
- Owner agrees to be responsible for all veterinary costs provided to your animal.
- Owner agrees to release, indemnify, and hold harmless RR Professional Dog Training from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to RR services, except which may arise from the gross negligence or intentional and willful misconduct of RR.
